We are excited to announce that Karuna Care Services (KCS) will be participating in the first **A&I Avenues**Case Management Agency Fall 2024 Provider Fair! This event will take place on October 8th, from 4:00 PM to 7:00 PM at the Avenues building, located at 1665 Coal Creek Drive, Lafayette, CO.

The fair will welcome over 1,400 individuals and families currently being served through the Intellectual/Developmental Disabilities (IDD) waivers, Family Support Services Program (FSSP), and the Autism Spectrum Disorder (ASD) Program in Boulder, Broomfield, and Gilpin counties. Families will have the opportunity to explore potential providers, ask questions, network with others, and receive assistance from Avenues staff.

Nurse's Corner: Flu Season

The CDC recommends everyone 6 months and older get an influenza vaccine every year. Influenza vaccine has been shown to prevent millions of influenza illnesses, tens of thousands of hospitalizes, and thousands of deaths each year.

When should you get vaccinated?

Ideally, between September and October. However, you can get the vaccine throughout flu season as long as influenza viruses are circulating.

Why should you get vaccinated?

You will be protecting yourself and the people around you who may be more vulnerable to serious flu illness like children, older adults, pregnant people, and people with certain chronic health conditions. Vaccination of people at higher risk of developing serious flu complications will decrease their risk of severe flu illness.

Prevention

- Avoid close contact with people who are sick.
- If you are sick, limit contact with others as much as possible to keep from infecting them. Wear a mask if you must be around people or go out in public.
- Cover your mouth and nose with a TISSUE when you cough or sneeze. Please do not use your hands for coverage!
- Wash your hands often with soap and water or use an alcohol-based hand rub. This is the best way to prevent the spread of illness.
- · Avoid touching your eyes, nose, and mouth as this is how germs spread.

Extra Information

The most common side effects from the influenza shot are soreness, redness, tenderness or swelling where the shot was given. If side effects do occur, they usually begin soon after vaccination and are mild and short-lived.

The side effects of the vaccine are much less severe than symptoms often associated with flu illness. Some people who get a flu vaccine still get sick, however, vaccination can make their illness less severe.

Talk to your healthcare provider before getting the flu vaccine if you have severe allergies to the flu vaccine or any ingredient in the vaccine.
